### **SENIOR AND TOTALLY DISABLED HOMEOWNER'S TAX RELIEF PROGRAMS**

The Assessor's Office has begun the 2025 Grand List application process for the State and Town Senior and Totally Disabled Homeowner's Tax Relief Programs. The application filing period runs from February 1, 2026 through May 15, 2026. **You may be eligible for a tax benefit on your real estate property taxes if you meet the criteria listed below.**

#### **STATE BENEFIT QUALIFYING CRITERIA:**

- Must be 65 years of age by Dec. 31 of the preceding year or totally disabled and receiving social security benefits
- Must own the home or have deeded "Life Use" recorded on the Monroe land records by preceding Oct. 1<sup>st</sup>
- If property is held in a Trust, the applicant and spouse must be the grantor and beneficiary
- Must occupy the home as your principle residence for more than 183 days during the year
- Total household income must not exceed **\$46,300** for unmarried and **\$56,500** if married

#### **TOWN BENEFIT QUALIFYING CRITERIA:**

- Must be 65 years of age by Dec. 31 of the preceding year or totally disabled and receiving social security benefits
- Must own the home or have deeded "Life Use" recorded on the Monroe land records by preceding Oct. 1<sup>st</sup>
- Must occupy home as your principle residence for more than 183 days during the year
- Must have been a Monroe taxpayer for at least one year immediately preceding receipt of tax relief
- Must be current on all Town of Monroe taxes
- Total household income must not exceed **\$75,000**
- **Please note beginning for the 2024 Grand List the income ceiling has been increased to \$75,000 for this program.**

#### **APPLICATION REQUIREMENTS:**

\*Please note that proof of income is **REQUIRED** when filing for a benefit. Applicants need to have completed their Federal Income Tax Return before applying for benefits and provide the following:

- A fully completed copy of your current Federal Income Tax Return
- Social Security 1099 Form (all recipients)
- Signed and dated State and Local Tax Relief Applications
- All other income per household
- \*Copy of Trust - if applicable

**Please note additional benefits or programs may be available if you are a veteran, renter, or surviving spouse.
